**SDNP/13/00557/HOUS - Fernden Heights, Square Drive, Fernhurst, Haslemere. New orangery to side elevation.**

It was proposed by Mr. Chapman and seconded by Mrs. Braithwaite that the Parish Council recommends approval of the application. Carried.

**SDNP/13/00390/TIME & - Stanley Farm, Highfield Lane, Lynchmere, Liphook. GU30 7LW.  
13/00392/TIME Extension of time of extant planning permissions FH/09/04820/DOM & FH/09/04821/LBC. Construction of 1 no. single storey extension to existing dwelling house, change in use of existing hay barn into uses ancillary to enjoyment of existing dwelling and construction of 2 no. single storey extensions to existing outbuildings and stables.**

- It was proposed by Mrs. Braithwaite and seconded by Mrs. Timms that the Parish Council objects strongly to this application that would create a new dwelling in the countryside, within the South Downs National Park, contrary to planning policy. Carried.
