**FH/11/05255/DOMNP - Mr. G. Bulhan, Woodlands, Van Common, Fernhurst, Haslemere. Replacement of existing outbuilding to provide home office, games room and storage.**

It was proposed by Mrs. Braithwaite and seconded by Mr. Chapman that the Parish Council recommends approval of the application. Carried.

**FH/11/04985/TCANP - Mr. E. Pezier, St. Margarets Church, Church Road, Fernhurst, Haslemere. Notification of intention to reduce height down to 6/7 metres (to top of clematis) and reduce north-west sector by 2/2.5 metres (to give clearance from The Old Rectory) on 1 no. Yew tree.**

An objection to the application had been received from the Church Wardens, who pointed out that the Yew tree is in the churchyard and is in their ownership as custodians. Whilst they have no objection to the removal of the overhanging branches, they will not agree to the proposed reduction in the crown of the tree.

It was proposed by Mr. Chapman that the Parish Council objects to the reduction in the crown of the Oak tree but would agree to the branches on the north-west sector being cut back in line with the south elevation of The Old Rectory. Carried.
