FH/11/05224/ELDNP - Mr. N. Clarke, Brackenwood, Telegraph Hill, Midhurst. Two water storage tanks.

It was proposed by Mrs. Braithwaite and seconded by Mr. Smith that the Parish Council recommends refusal of the application as the storage tanks are for uses for purposes which themselves have not been approved.

Also, it is of great concern to the Parish Council that the site contains stables, a large shed, a polo field and a groundsman's chalet, all of which have been refused. We urge that the enforcement team takes appropriate action with regard to this site and advises the Parish Council what action has been or is to be taken. Carried.
